It's Time for Spring Cleaning...

Account Ownership: It is good practice to review your account ownership. Contact the Credit Union to confirm your joint owners and/or beneficiaries.

Forgotten Accounts: Do you have any Forgotten Accounts? Check with the Credit Union to see if vou have any dormant accounts.

Address-Phone Changes: Have you moved to a new address? If so, please contact the credit union to update your address and/or phone number.

Home Banking: We recommend changing your Logon ID from your member number to a more unique Logon ID. Minimum length is 6 characters. Do not use social security number, email address, or your member number when changing your Logon ID.

No Time Like The Present For IRA Contribution...

Procrastinators rejoice: it's another lucky year for you. Usually, the tax return filing deadline is April 15th. However, in 2017, April 15th falls on a Saturday and the Washington D.C. Emancipation Day holiday will be observed on April 17th instead of April 16th, 2017. Thus, Tax Day for your 2016 return is on the following Tuesday: April 18th, 2017. That means you have a few extra days to file your taxes as well as to open or contribute to an Individual Retirement Account for the 2016 tax year.

But the sooner you do so, the better, so your tax-advantaged savings have longer to grow. Your total contribution to both a Traditional and Roth IRA for the 2016 tax year is \$5,500 (\$6,500 if you are 50 or older), or your taxable compensation for the year, if your compensation was less than this dollar limit. IRS Publication 590-A has details; find it at www.irs.gov.

Get Your Annual Free Credit Report...

Under federal law, you are entitled to one "free" copy of your credit report every 12 months from each of the nationwide credit reporting companies (Equifax, Experian, and TransUnion). A special website, https://www.annualcreditreport.com, has been set up by the three major credit-reporting companies. Just go to the website and click the "Request your credit reports" button and follow the steps. There is no charge for ordering your annual credit reports.

You may order your reports from each of the three nationwide credit-reporting companies at the same time, or you can order your report from each of the companies one at a time. Your best option is to space out your requests so you get a credit report every four months.
