## 2025 Annual Meeting and Election Notice

Johnsonville TVA Employees Credit Union will hold its 2025 Annual Meeting on April 5th, 2025, at the Briarwood Elementary School in Camden, TN at 10:00am where its newly elected directors will be announced.

The Nominating Committee has nominated one member for each Board position to be filled. The three nominees are Sherry Beasley, Corey Christopher and Cindy Eblen. A brief bio on each is listed below.

**Sherry Beasley—Three Year Term.**

**NOMINATIONS BY PETITION – 2025**

Johnsonville TVA Employees Credit Union’s official petitions must be signed by 1% of the membership (a minimum of 104 signatures of members in good standing) filed at the Johnsonville TVA Employees Credit Union’s office located at 209 Hwy 641 North, Camden, TN 38320 by February 10th, 2025, which is the closing date for receiving nominations by petition. If no official petitions are filed by February 10th, 2025, there will be no election by ballot and no nominations from the floor. When only one member is nominated for each position to be filled, each nominee shall be deemed elected by general consent or acclamation. If there is more than one nominee for any position, the election shall be by in-person vote at the Annual Meeting April 5th, 2025.

**PROTECTIONS UNDER REGULATION E**

Regulation E, also known as Electronic Funds Transfer Act, outlines the rights, liabilities and responsibilities of consumers that use electronic services. Electronic Fund Transfer services include but are not limited to Debit Card, Online Banking, Bill Pay, Mobile Banking, Automated Clearing House (ACH), and Automated Teller Machine (ATM) transactions. These rights, liabilities and responsibilities are described in the Electronic Funds Transfer Agreement and Disclosure that you received at account opening.

Our Debit Card Fraud Prevention provider, Fiserv Card Services, may contact you by phone from 833-735-1894 or by text from 20733 on behalf of Johnsonville TVA ECU Fraud Alert. If contacted by phone you may be asked to call back at 833-735-1894. If you receive a text message, you may be asked to call back at 833-735-1892. If you are uncomfortable with the call at any time you receive, you may hang up and call back at 833-735-1894 or contact the credit union during normal business hours at 800-338-4609. Our Credit Card Fraud Prevention provider, Fiserv Card Services, may contact you by phone from 833-763-2018 or by text from 20733 on behalf of Johnsonville TVA ECU Fraud Alert. If contacted by phone you may be asked to call back at 833-763-2018. If you receive a text message, you may be asked to call back at 833-763-2021. Fiserv Card Services will NEVER ask for your whole card number, expiration date, PIN number, or online banking credentials. They may ask you to verify your mailing zip code, the last four digits of your card number, and/or the amount of your last valid transaction or payment. For the Fraud Prevention program to operate at its highest level, please contact JTVAECU to update your cell phone number(s) and email address. Also, contact the credit union to update any travel plans.
